The grievances or problems of the students regarding the examination or any related issues are addressed at two different levels those are College level and University level depending on the nature of the issues. The college receives minor grievances from students, supervisors, invigilators, college examination officers and stakeholders. Any problems related to the internal assessment are handled with the proper system through examination department whereas any problems related to external assessments are forwarded to the university through proper channel. The facility of photocopying, rechecking and re-evaluation is provided to the students. Examination department always provides the time bound solutions for the queries raised by the students. All the problems are entertained without exception and are resolved within reasonable time and transparency is maintained by providing photocopies of the answer sheets to the students as per their demand. All the notices and the instructions about the examinations are displayed on the college website as well as on the display boards at the entry point. Internal Squad is appointed by the exam department to keep vigilance. Examination scheduled timely updated on website and social media groups. Each teacher prepared three sets of multiple-choice question papers for each theory course. Before the examination, Mock tests were scheduled and conducted to make students familiar with the process and resolve queries. Five minutes before the examination time, the Internal Examination Committee notified the concerned staff members to upload one selected paper set on Learning Management System (LMS) Moodle

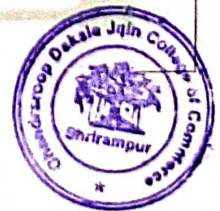
